## II. Summary

\*\*\*\*\*

Another insanely busy month, covering 796 individual email threads.

A good portion of my time has been spent on conflict resolution between members, disciplinary actions, mediation and investigation. Members should exercise some discretion when calling for appeals. Not every decision that affects you negatively should be appealed. Only those decisions which are clearly incorrect in the way they were made are likely to be reversed. An officer simply exercising her own best judgment in a way other than you feel you would rule, or even differently than her supervising officer, is not grounds to overturn a decision. So long as it is a reasonable course of action, that decision will stand. To appeal a decision, you must submit a letter of appeal within 30 days of the decision to the original officer, the officer(s) to whom the decision is appealed, and to your direct coordinator.

Members are expected to be courteous and cordial whenever they are not in character. Compliments should be as frequent as possible and criticism should be constructive. Members who have a personal issue with another member have a responsibility to handle it calmly through the dispute resolution procedures. Dishonesty is disrespectful. Members shall be honest in their dealings with other members. Members should avoid spreading information at Camarilla functions and over Camarilla forums that is hurtful to other members, particularly information that is secondhand or potentially incorrect.

On the positive side, we have also seen an increase in the number of new chapters and returning members. Still time is consumed with setting up new chapters, approving transfers and rebuilding logs. I urge members to take advantage of the national lock process, so that your records are archived somewhere in case they have a system crash or other situation which results in lost records.

Josh Humble - USANC Arbitration - will be transitioning to another role, as such I am in the process of reviewing applications and moving into the second phase of hiring for that position. Sean Mooney - USANC Prestige - will be transitioning to another role, I just began the process of accepting applications for that position.

NWRC Elections are complete - Welcoming Federico Diaz, to the RC panel and getting him on the appropriate lists

Elections and voting - Just a reminder that per the Camarilla Constitution votes are cast via secret ballots. Secret ballot choices are confidential. The key aim is to ensure the voter records a sincere choice by forestalling external attempts to influence the voter

I'm going to be issuing a call for project leads for a couple of projects that need to get done. Look for those as well in the next couple weeks.

I'm gonna unabashidly steal this idea from Jon (and I dont feel that bad about doing so :) ) "Gimme 5." We often get into a rut, doing what we do at each game or meetings, and hanging with the same folks. I'm asking each member and officer in the US Cam to "Gimme 5." Give 5% of your time to something for the future of the club. We all do present-day stuff, and that's great. Just take 5% of your time and give it to building the Cam of the future.

I. For members, that may mean that if you've played a four-hour game, give 10 minutes or so to talking to the new people or to chatting with someone at the WW rack of your friendly local gaming store about how much you enjoy the Cam. Recruiting is a key to the future, as is retention and enjoyment of the players we have now

II. For officers, that means planning beyond your term of office a bit. You spend hours each month thinking about what you need to do right now, and soon. Take 5% of that time and mentor a newer member, if you're a Coord take the time to walk new members though the prestige system, How to renew, Explain the ordeal system, or transferring. Do those things that will make the experience of those who come after you better- just 5% of your time.

Question: What is the policy on Disciplinary Actions and running for office after said DA? The Membership states that "once a disciplinary action has been enacted and completed, the member is back in good standing with the Camarilla and is encouraged to return to club activities immediately." How soon after a Disciplinary Action can a member be allowed to run for an elected office? Please clarify.

That is correct, however the MH also states (Under the election procedure) = "After the application deadline, the officer administering the election reviews the applications. The officer may remove any applications that are inappropriate. Legitimate reasons for removal of an applicant include past disciplinary actions or an applicant's unwillingness or inability to meet the minimum standards of the office"

Typically Disciplinary actions within the last year are closely reviewed during application review and may result in removal from the candidate list.

Question: When shall the Membership Handbook revisions be completed? Is any assistance needed in its completion?

Currently there is no solid deadline for completion of revision of the MH. Its an on-going process.

Question : As its taken way too much time to get our prestige for NERE to be official, is it possible because its only regional prestige, that I could just ok it? It?s somewhat ridiculous its taking this long and my region has been very patient.

Question : Any reason why the Camarilla Council?s actions have to be so secret? The recent removal of the NW RC is sort of shocking to the say the least. More so when the person responsible for the NERE prestige has the time to vote on that but not get our prestige done.

The reasoning for, and actions taken, were detailed to the entirety of the NW region within 72 hours of the decision. The entire process for motions to the Camarilla Council, and procedures of the Council are listed in the Membership Handbook. While I can understand the importance many members place upon prestige, in practice there are other issues of the organization which must take priority over prestige at times.

Q: There's something I've always heard, but wanted it verified. I've always been told that temporary members can earn prestige, but (obviously) can't earn MC. That is, that stuff our awesome temp members do for us is still worth prestige for them, and that it adds on to their totals when they sign up for the permanent membership. Is this how it works?

A: Per the White Wolf Camarilla site under trial memberships – A trial member may not benefit from prestige earned unless a full membership is purchased. So a trial member may earn prestige, but can not apply for MC advancement until such time that they are a full member.
